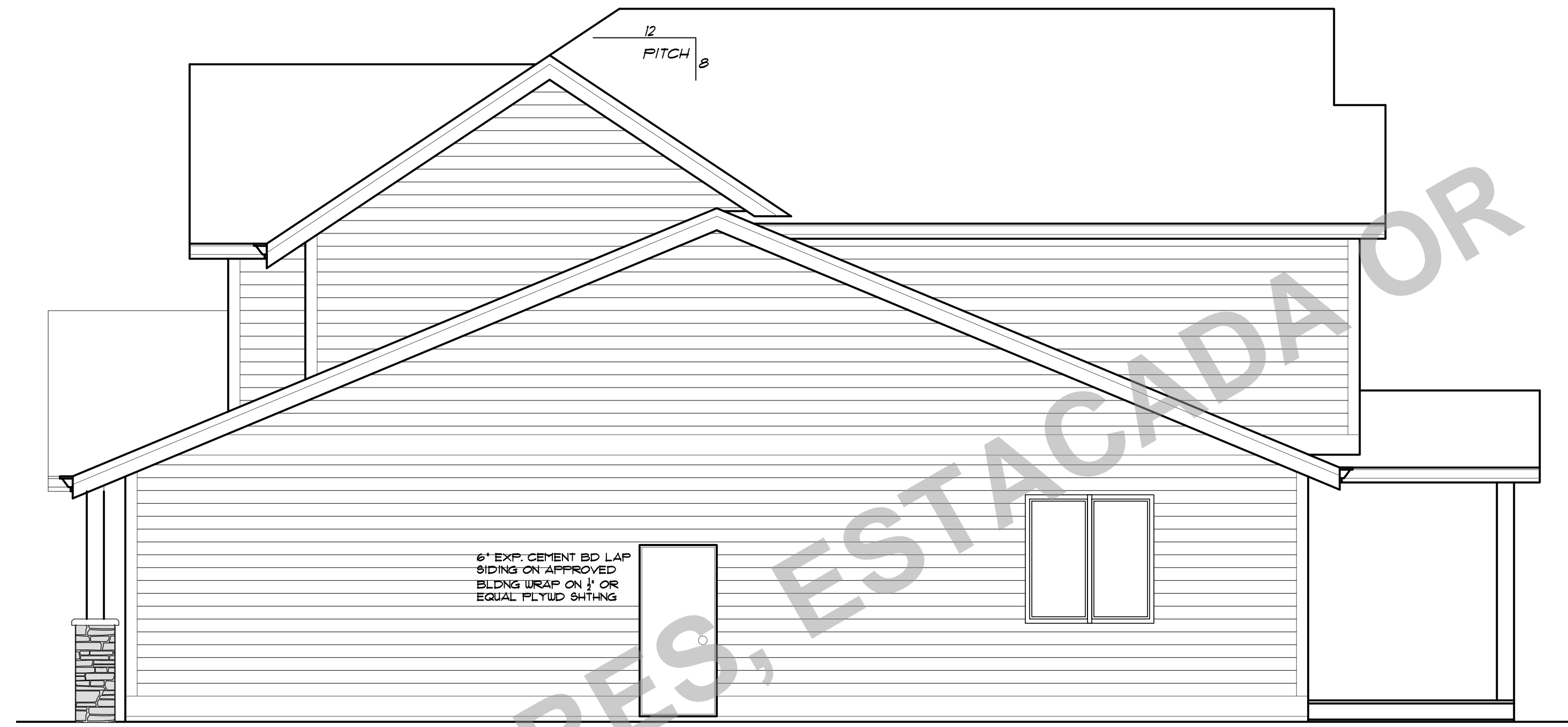
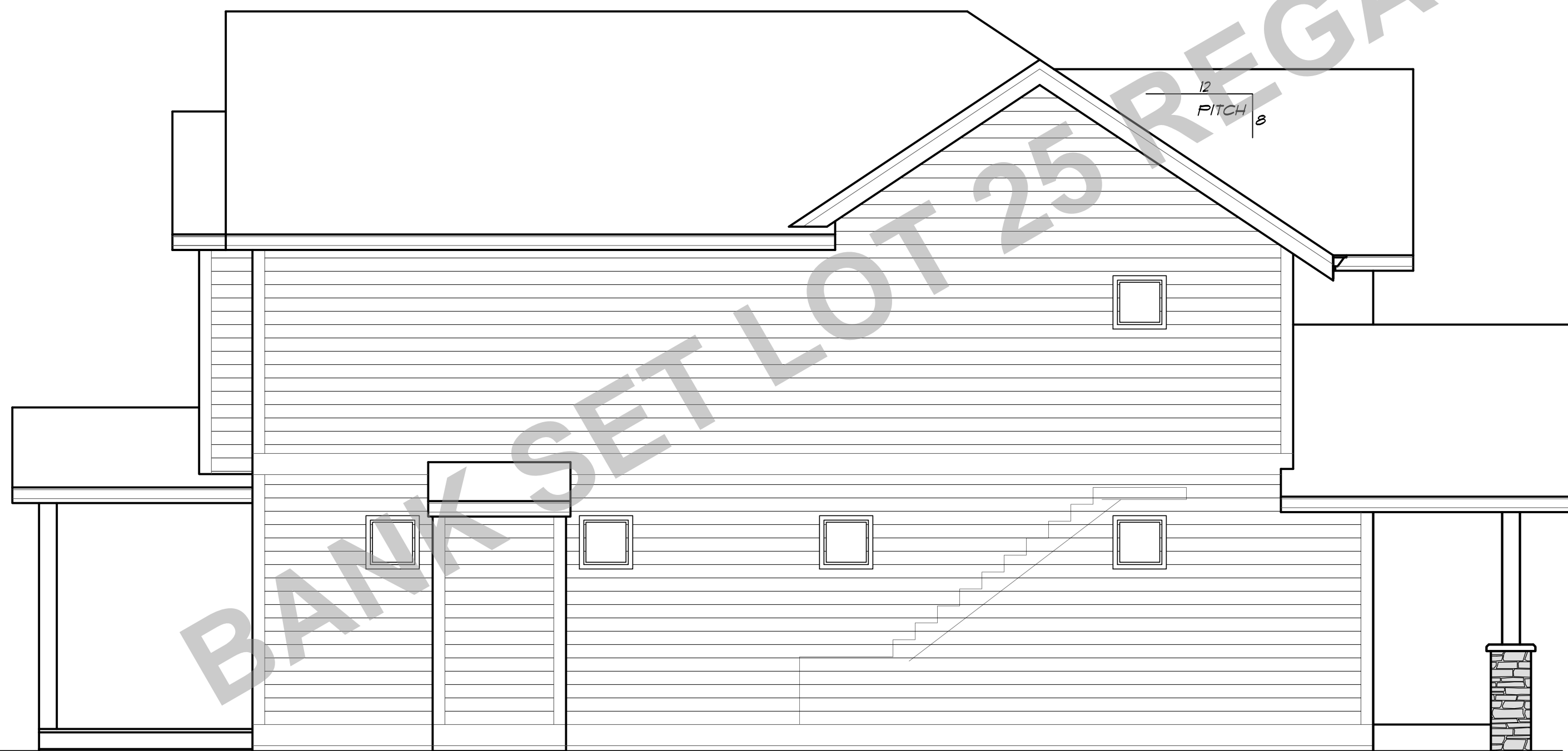




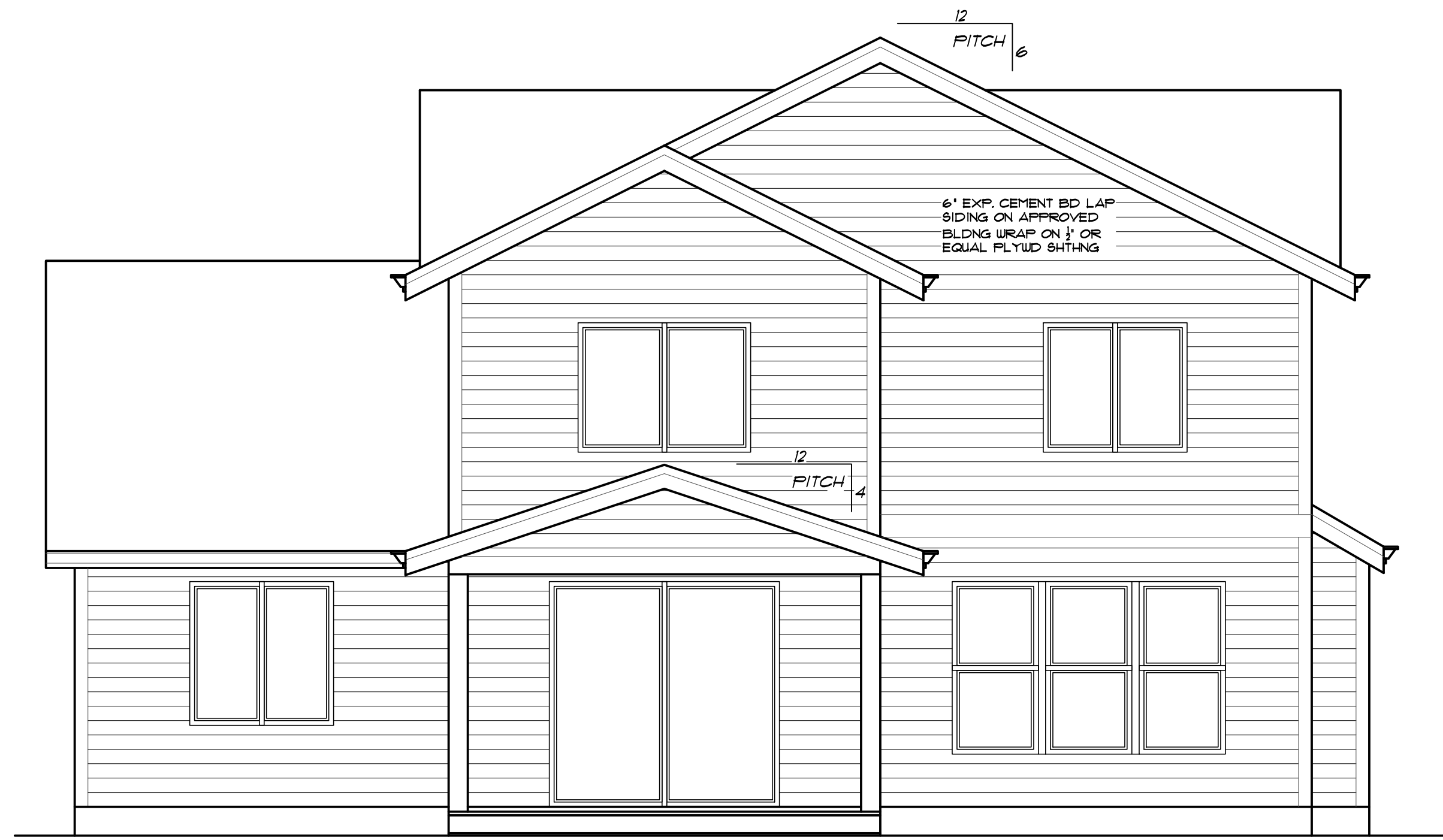
FRONT ELEVATION

LEFT ELEVATION



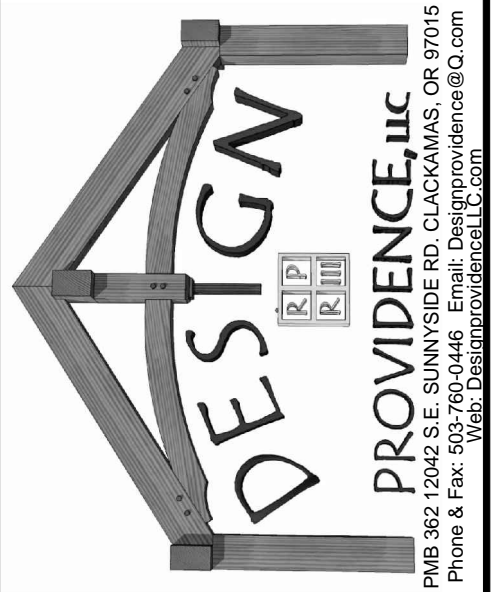

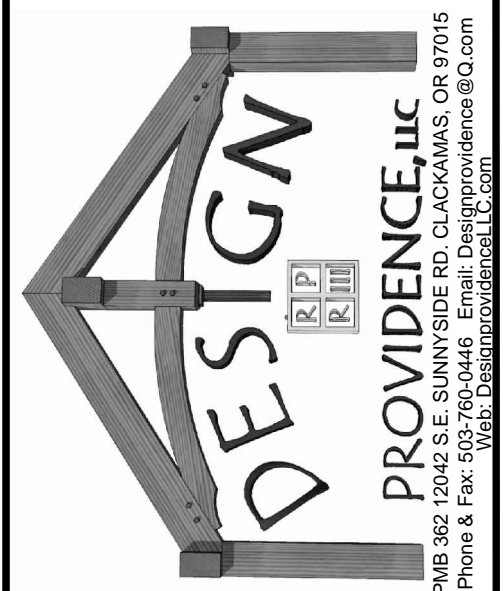
