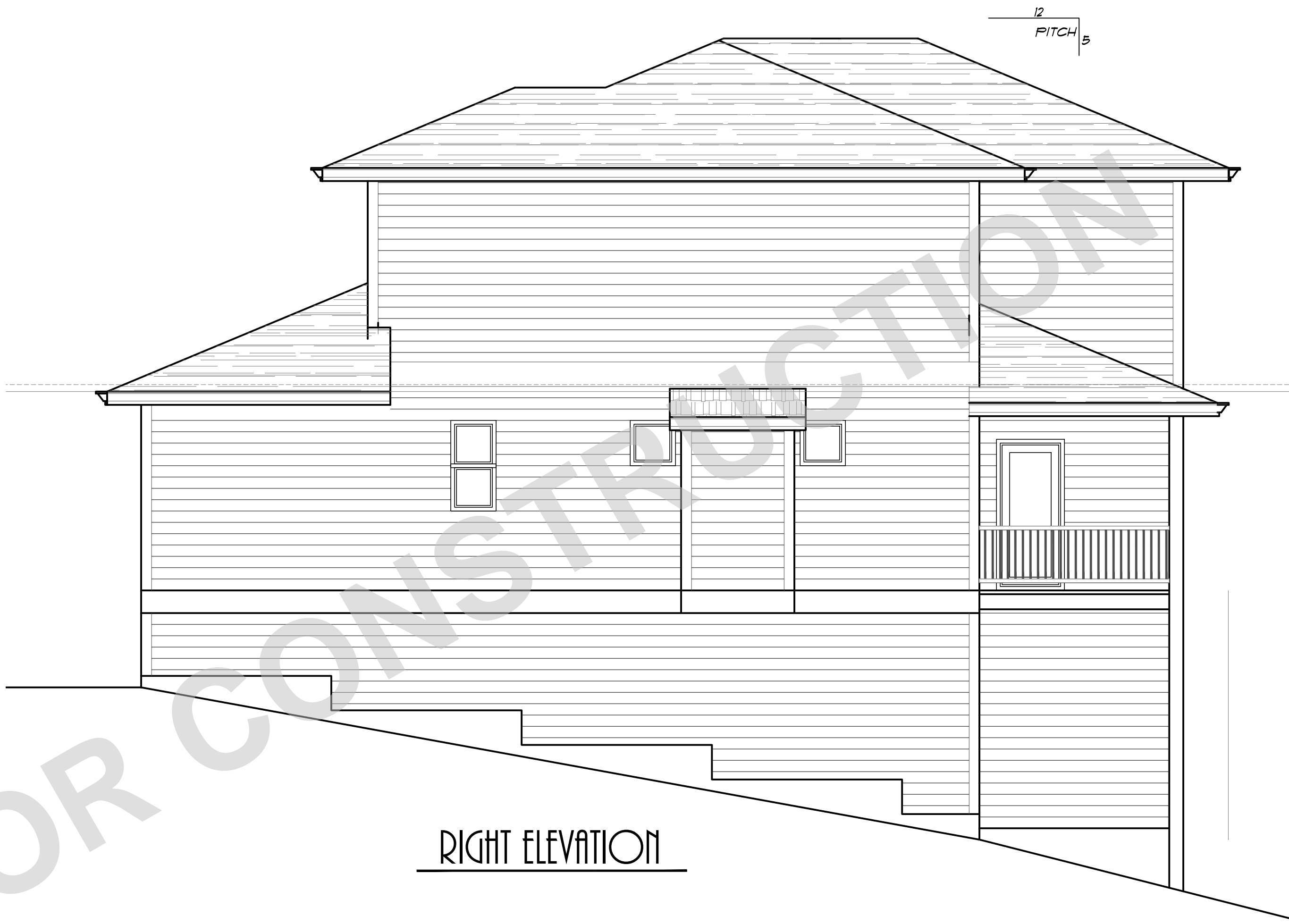
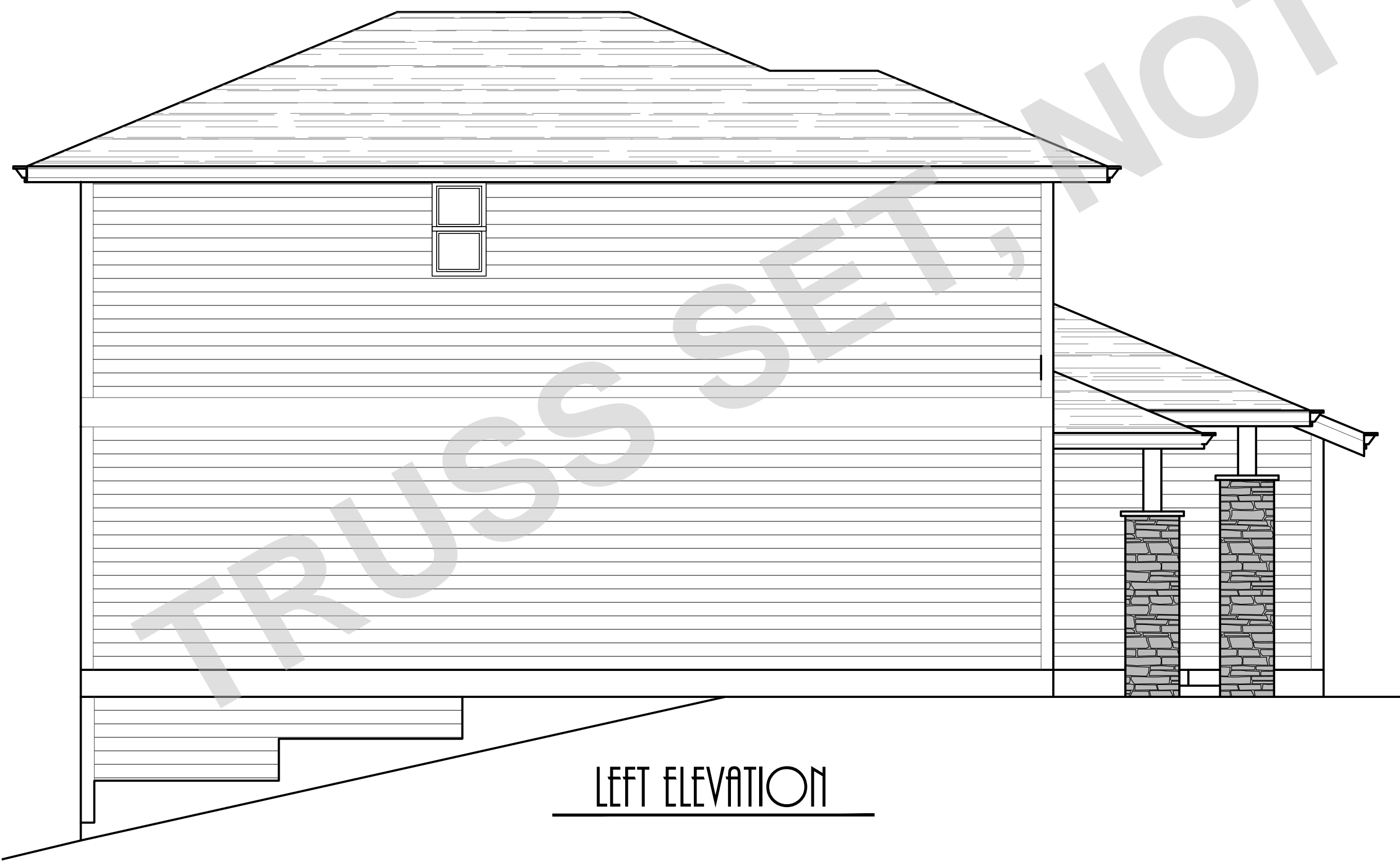




FRONT ELEVATION

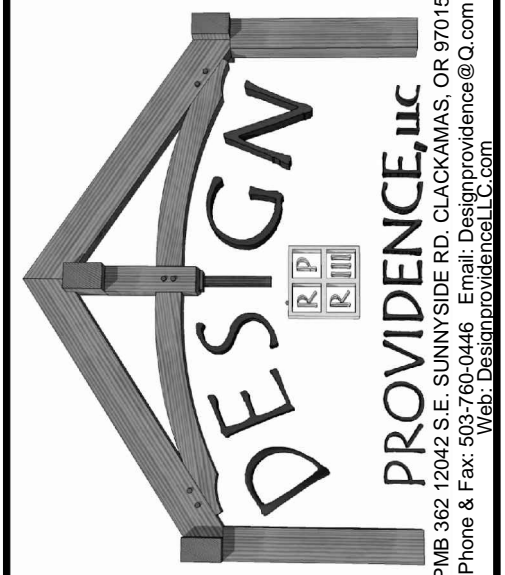
