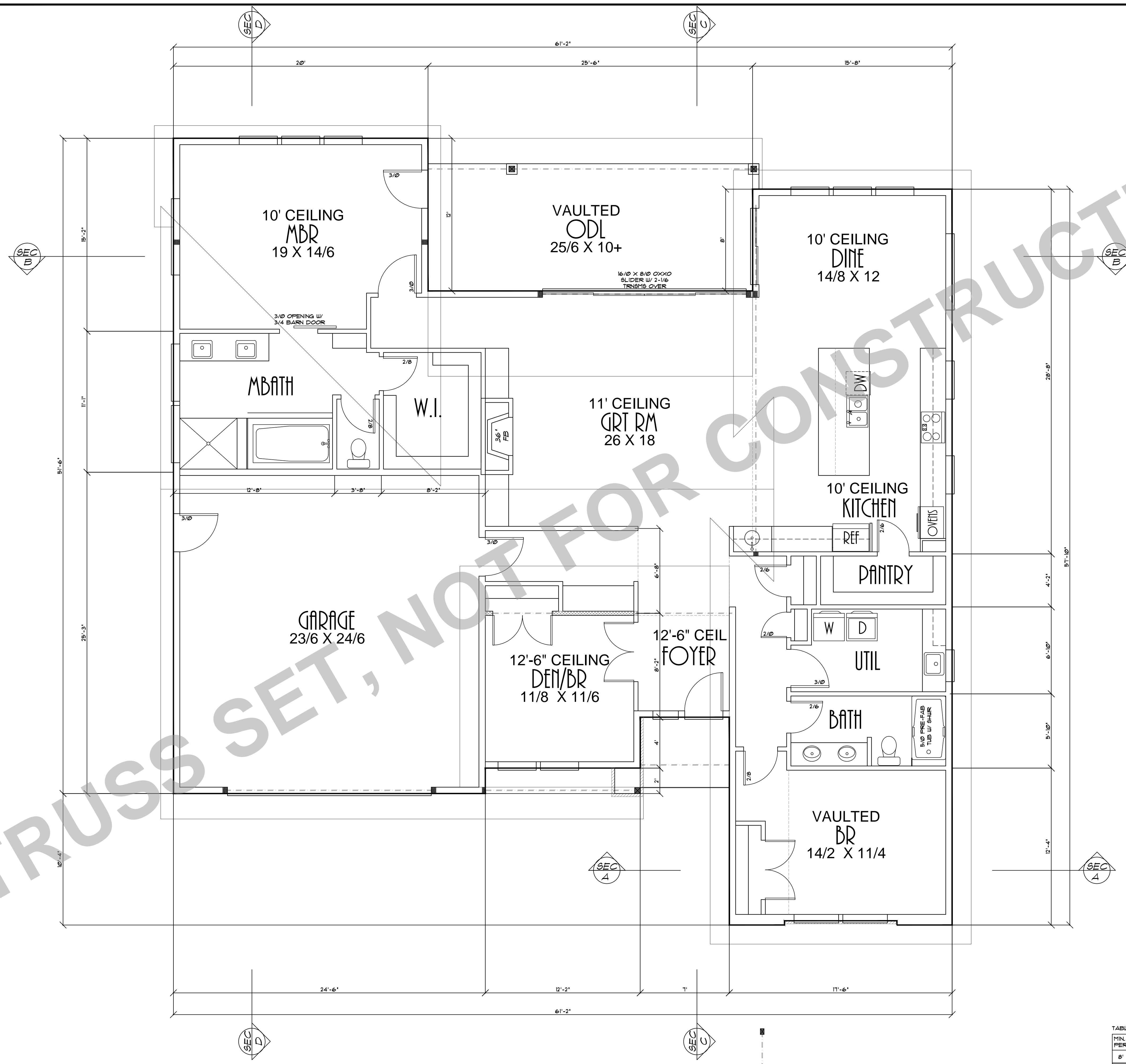

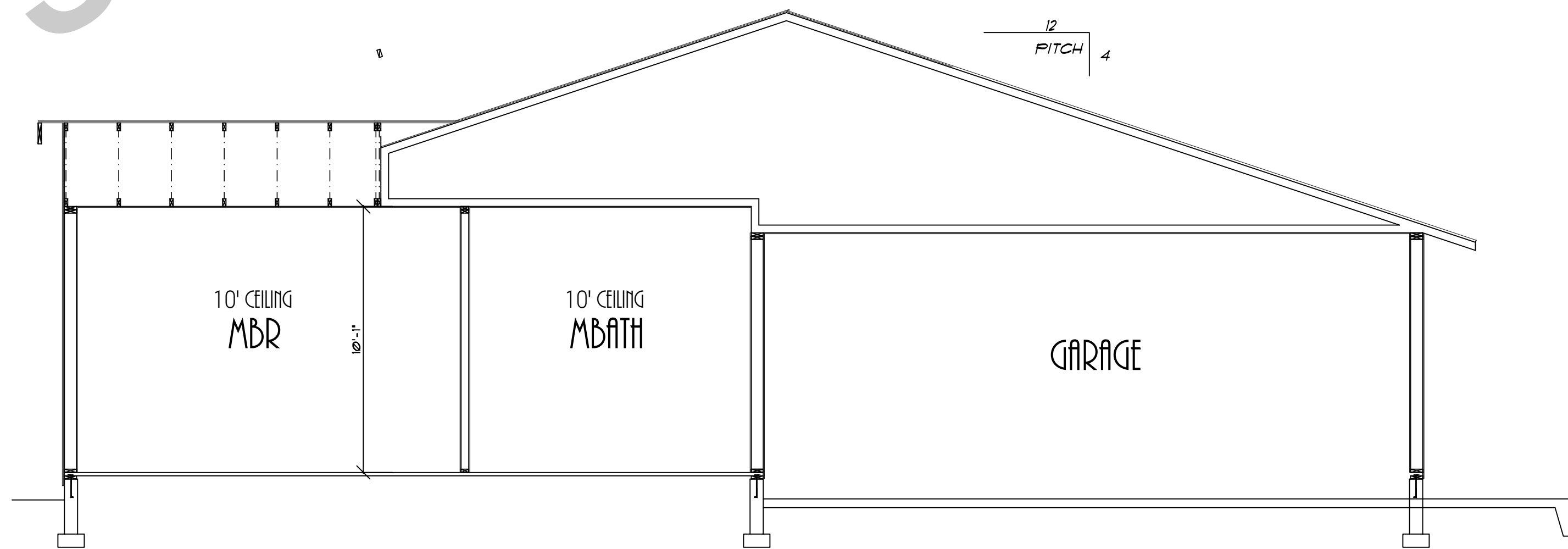
CROSS SECTION A-A

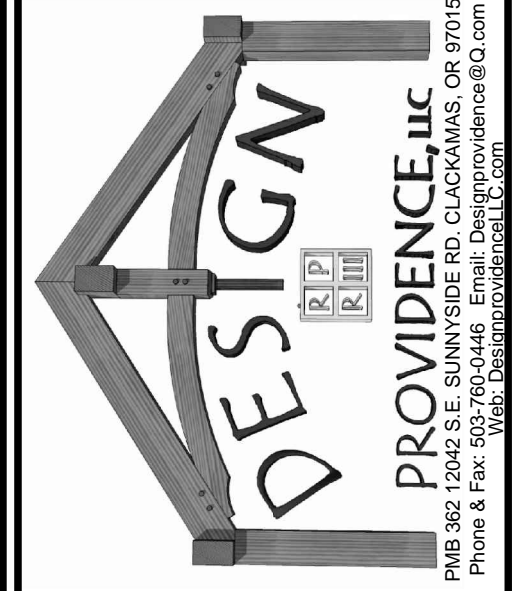

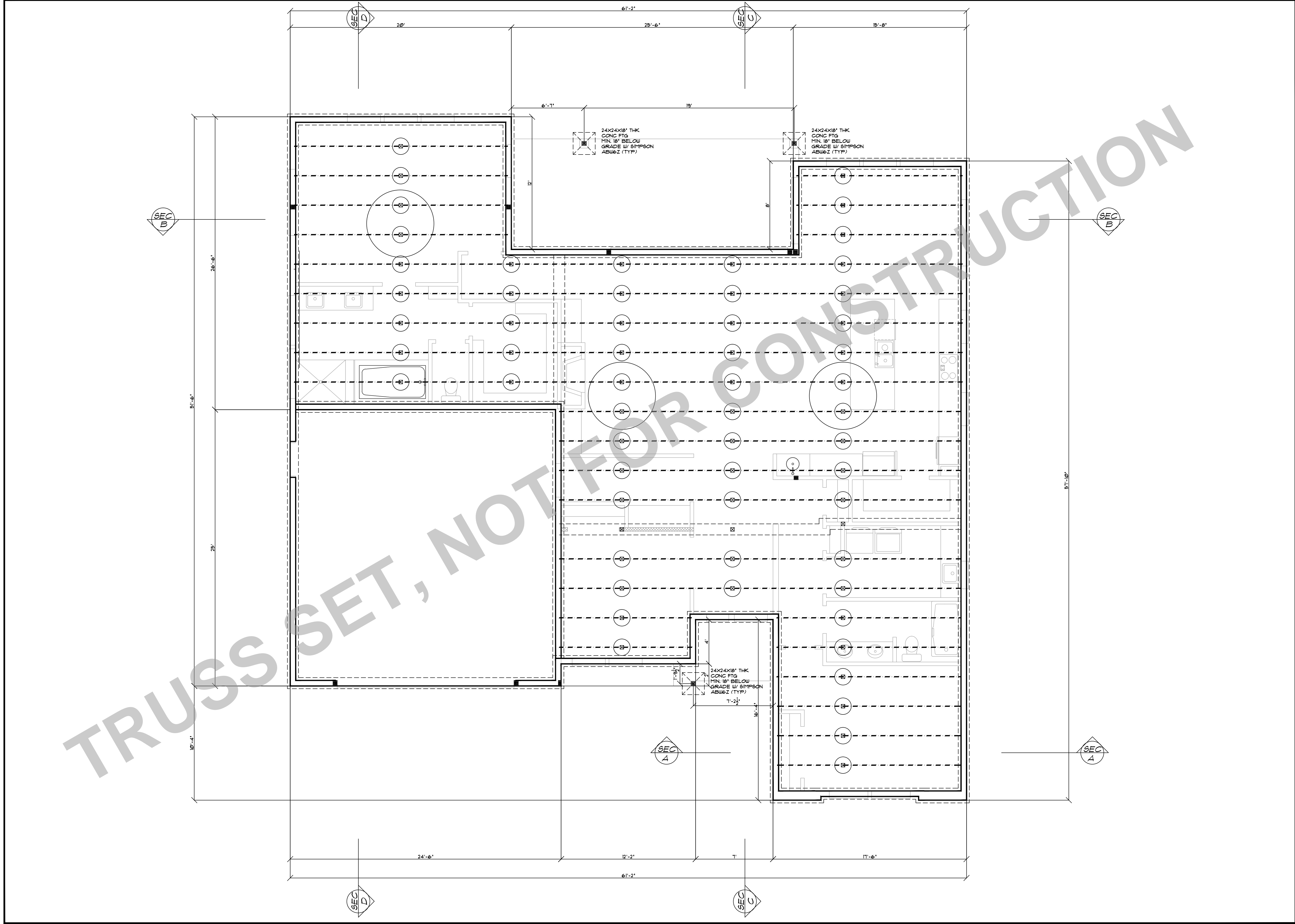

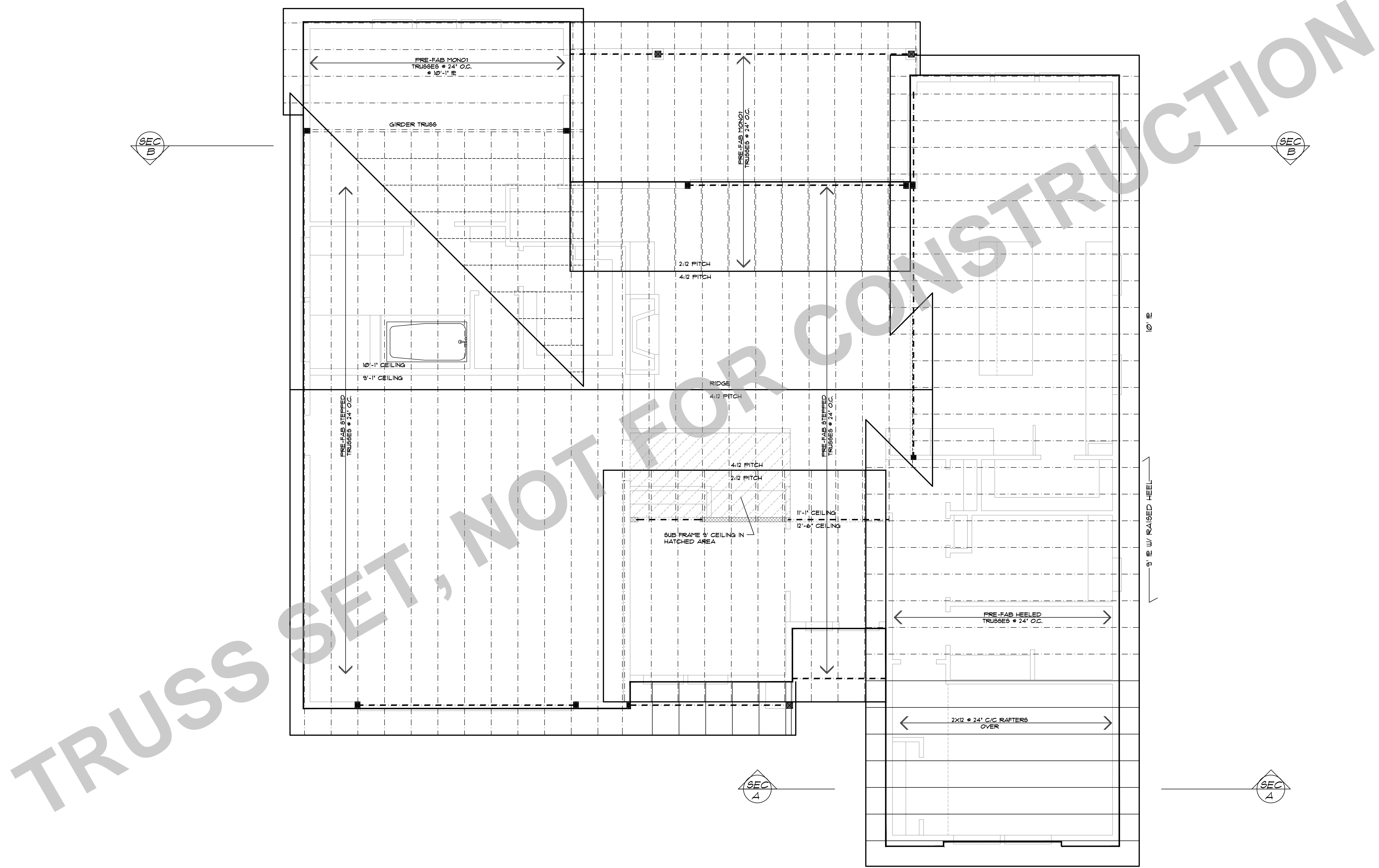
